Goal of the Pro Bono Faculty Consortia

To improve the provision of student-run pro-bono health services to those in need.

Purpose An organization to facilitate collaboration between faculty members of regional pro-bono health centers to provide consultation in order to improve services, problem solve issues regarding delivery of services, and identify available resources in the specific regions.

Objectives for the Pro Bono Faculty Consortia

- 1. Provide opportunities for faculty from pro-bono centers to meet 2-3 times each year: CSM and Pro bono Regional Conferences and now perhaps a third with ELC
- 2. Share and discuss various DPT program's Student-run, Pro-bono clinic educational models and student-run pro-bono health services.
- 3. Establish a faculty network for scholarly support and mentorship in student-run clinic investigation and study.
- 4. Develop connections between faculty and students with similar leadership responsibilities in order to share ideas and improve processes, policies, and outcomes that arise in the provision of pro bono services for faculty, students, and clinicians/licensed supervisors.
- 5. Identify available resources in each of the pro-bono sites; facilitating regional development and possible regional centers enabling a mechanism to share resources and referrals to meet clients' needs.

Minutes

1. Meet, greet and orient

Discuss how the Faculty Consortium and the HPA Pro Bono Catalyst Forum link to one another. Overall we hope to structure our efforts in the following way:

- A. **HPA Pro-Bono Catalyst Forum:** addresses Faculty *and* Clinicians nationally who provide Probono services. Meetings occur at CSM.
- B. **National Pro Bono Faculty Consortium:** addresses Faculty of Student-run Pro Bono clinics nationally. Meetings proposed to occur at ELC.
- C. **Pro Bono Student Regional Consortia:** at this time there is a Philadelphia Regional Consortium (headed by Temple), a Mountain West Regional Consortium (headed by University of Utah), North Carolina Regional Consortium (headed by Elon University, and a Southeast Regional Consortium (headed by University of Florida).
- D. **National Steering Committee:** The National Steering Committee consists of the Regional Consortia student leaders. Student leaders hold regular conference calls to facilitate communication across regions and promotion of The Pro Bono Network and The Pro Bono Network Conferences.
- **E.** The Pro Bono Network Conferences: Widener University held the first Eastern Regional Conference 9 years ago. The conferences expanded to two geographic locations 5 years ago and to three last year.

Jodi Gilles, PT, DPT, Mark Bishop, PT, PhD, FAPTA, William McGehee, PT, PhD, Kevin Lulofs-MacPherson, PT, PhD, OCS, FAAOMPT, and Kim Dunleavy, PT, PhD, OCS, FNAP.
- Discussion across attendees occurred. Faculty from pro-bono Student- run Pro Bono Clinics (SRPBC) shared information; this was captured on large sticky notes and categorized under the following 6 main themes:

1. Models:

Supervisory models (senior:junior; outside clinical faculty; licensed volunteers; PT residents; "Community-Instructors ie community health workers)

Required Participation vs volunteer vs curriculum requirement vs/or program service policy requirement;

ICE/Free Standing/Curriculum (on campus); Interprofessional &/or collaborative care clinics;

Unique settings: Native American Clinic Setting; Outreach IP clinic within a underserved Highschool setting @KUMC 'Bulldoc'; "Two Account- agency"; Food Pantry/shelters/Faith based/Cmty Centers.

Trauma Center connections for non-documented community members;

Discharge from a SRPBC; possible solution is to discharge to an affiliated Community Wellness Center
